ADA Accessory Dimensions



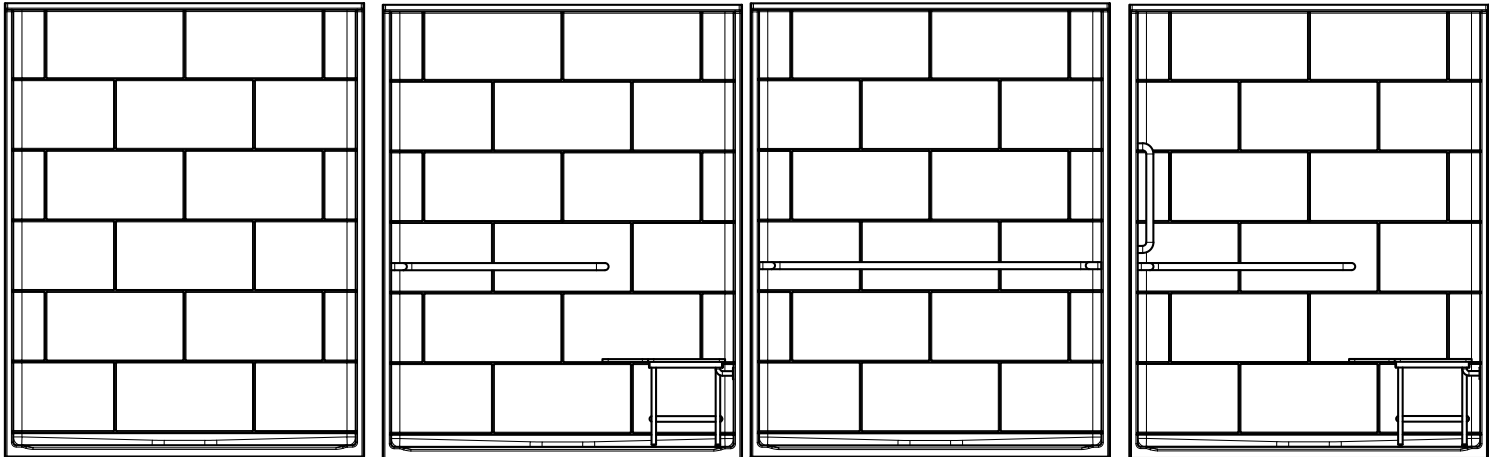

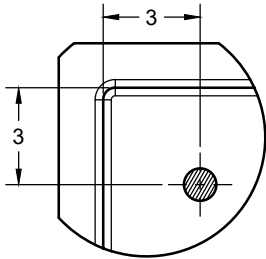

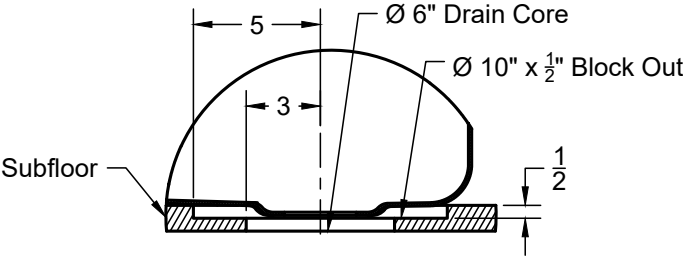
